

19:00 – Doors Open 19:15 – Lecture 20:00 – Q&A 20:30 – Mixer The Trump administration may pose unprecedented risks to the U.S.-China economic and trade relationship, or it may result in little change to the underlying structural factors which have determined the course of the U.S.-China relationship in the last 25 years. While the Trump-Xi summit provides valuable clues to what to expect going forward, the past also inevitably structures the course of any possible change. Tonight's talk will focus on both sentiment in China among Chinese policy-makers and sentiment among U.S. businesses in China. Discussion will revolve around risks, uncertainties, and forecasts for U.S. business in China.

Andrew Gilholm is a Principal and Director of Analysis in the Global Risk Analysis team at Control Risks. He leads the analysis practice for Greater China and North Asia, and oversees coverage of political, regulatory and security issues across Asia. Andrew has worked in the political risk industry for 15 years and led Control Risks' China analysis for more than 10 years. His comments, analysis, or op-eds have appeared in media and journals including the China Economic Quarterly, Journal of Contemporary Chinese Affairs, Financial Times, Wall Street Journal, The Economist, and Time Magazine, and in broadcasts by the BBC, Bloomberg, and CNBC. Andrew holds an MA with distinction in East Asian politics and international relations, and a BA in political science.

Kenneth Jarrett is President of the American Chamber of Commerce in Shanghai. Previously Chairman for Greater China at APCO Worldwide, Mr. Jarrett was also a U.S. diplomat for 26 years, whose assignments included U.S. Consul General in Shanghai, Deputy Consul General in Hong Kong, and Director of Asian Affairs in the National Security Council, serving in Singapore, Manila, Beijing, Chengdu, and Washington, DC. He holds degrees from Cornell, Yale, and the National War College, and is a member of the National Committee of US-China Relations. He also attended the Hopkins-Nanjing Center, and is among its most distinguished alumni.

<u>Owen Haacke</u> is Chief Representative at the Shanghai office of the <u>U.S.-China Business Council</u> (USCBC) where he works with U.S. member companies to inform and advocate for U.S. companies doing business in China. Owen coordinates targeted research and intelligence on best practices, operational issues, and policy changes that impact the operations of US companies in China. Before joining USCBC, he worked on international trade policy for former Senator Max Baucus and at the U.S.-China Economic and Security Review Commission. Owen holds a BA from Dalian University of Foreign Languages in Chinese, International Economics, and Trade.
