The Cyber Security Law of the People's Republic of China promulgated on 7th November 2016 has come into effect since 1st June 2017. As the first comprehensive law in China governing cyber security, the Cyber Security Law has formulated a number of new legal concepts and requirements involving network operators, critical information infrastructure, security review, and security assessment, and imposes extensive compliance obligations, especially on foreign-invested enterprises in China. With the intensive promulgation of the relevant implementing rules, companies operating in China are facing compliance challenges of cyber security and data protection. This talk introduces the recent legislative and law enforcement activities and explores compliance strategies for foreign-invested enterprises in China.

Zhou Yang is a partner at Zhong Lun Law Firm Shanghai Office. Before joining Zhong Lun, he practiced with Baker & McKenzie LLP Shanghai Office and Freshfields Bruckhaus Deringer LLP Shanghai Office respectively.
