In 2015, the signing of the Paris Agreement marked the first moment nations came together 'into a common cause to undertake ambitious efforts to combat climate change and adapt to its effect, with enhanced support to assist developing countries to do so." Ambitious targets are being set, and last September China pledged to peak CO2-emissions before 2030 and reach carbon neutrality by 2060. The EU aims to be climate-neutral in 2050, and both China and Europe are undergoing a crucial energy transition. The path from a fossil-fuel based system to a system based on renewables is a bumpy road and is not without challenges. During this talk, the speakers discuss the energy transitions in both Europe (and in particular the Netherlands) and China. They will also discuss whether the global priority of reducing CO2 emissions and achieving carbon neutrality paves the way for more international collaboration.

Fleur Edens is Senior Economic Policy Officer working at the Economics Department pf the Consulate General of the Kingdom of the Netherlands in Shanghai. She is working on the topic of energy transition and aims to strengthen Dutch-Sino collaboration in this challenging and increasingly fast-developing domain. She is focusing on a variety of sub-areas ranging from offshore wind and solar energy to hydrogen. Aside from being the contact person for Dutch companies and helping them entering the Chinese market, Fleur also follows the policy developments closely in order to identify possibilities for further international collaboration. Prior to her current position Fleur worked for the Dutch Ministry of Foreign Affairs in the Hague, Beijing and Manila.

Mickael Naouri is Director of Corporate Affairs at Air Liquide. Among his corporate responsibilities, he is in-charge of developing the strategy and market knowledge for Air Liquide's hydrogen energy business line in Asia-Pacific, while interacting with local and foreign governments on various topics to increase the visibility of Air Liquide.

Li-Xiong Chu is Senior Advisor at Dr2 Consultants. A Dutch-Chinese born and raised in the Netherlands, he has worked and lived in Shanghai for 10 years.
