This talk will revolve around recent reforms and prospects for foreign firms in China's financial services industry. Jonathan Chapon will first share his thoughts about the recent reforms in the insurance industry, focusing on the development of the insurance sector in China, and on health insurance in particular, concluding with innovations in the insurance sector. Following this discussion, Han Lin will then provide commentary on parallel sector reforms along the broader financial landscape (banking, securities, asset management, VC/PE, fintech, and payments), and economic context.

After graduating from a business school in France, he first came to China as an international student in 2007 and later joined Abacare, where he has worked for 12 years.
