This talk will engage the audience in the China economy by (1) looking at recent economic indicators, (2) summarizing key commercial-related themes from the Third Plenum, and (3) offering key predictions on the impact to foreign businesses.

Han Shen Lin is Associate Professor of Clinical Practice in the Finance Department of NYU Shanghai and is also the China Country Head at The Asia Group. Prior to this, he was a Senior VP and Deputy General Manager of Wells Fargo in China, where he helped lead the bank's China governance and oversaw its China corporate and commercial banking client coverage, strategy, and business development. Han received a BBA from the University of Michigan's Ross Business School, and later completed a Masters of International Studies at the Johns Hopkins School of Advanced International Studies (SAIS), a Masters of Science in Global Finance at the joint HKUST-NYU Stern program, and a Masters of Chinese Commercial Law at Fudan University Law School. Han has previously served on the Board of Governors of the American Chamber of Commerce in Shanghai, and has been the Chair of AmCham's Financial Services Committee.
